

Branchwater Policies in Response to COVID-19

- Branchwater will not provide chairs or crates. You are welcome and encouraged to bring your own for the duration of the lesson. *We will not store them for you.*
- Entry to the field will occur exclusively from the gate closest to the training center. There will be spray to wipe the gate and chain after each lesson.
- Branchwater buildings are closed to the public. This includes bathrooms. We will have wipes and sanitizer outside of a Port-a-Pot, along with a trash can for used wipes. You can dispose of bagged dog waste there as well. We recommend you bring your own sanitizer with you just in case we are unable to purchase it.
- Branchwater Training Center Agreement/Waivers should be signed in advance preferably virtually. Please make an attempt to sign the PDF or print and take a photo to send to your instructor **and** Branchwater (branchwaterbc@aol). If you are unable to sign using a method that is no contact, please reach out to your instructor prior to your lesson. Those without signed forms will not be permitted to complete their lesson or rent the space.
- Please practice social distancing and any other appropriate safe health practices recommended by the state
- All lessons are outdoors so they are weather dependent.
- All participants must wear masks brought from home at all times.
- *Instructors will set all equipment including resetting of bars. There may be need for help with an a-frame reset.*
- All participants should maintain a minimum of 6' distance at all times.
- DO NOT come to your lesson if you feel unwell, have a fever, display any of the COVID-19 symptoms or have knowingly come in contact with someone who has tested or is suspected of being positive for COVID-19.
